I hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expenses (including legal fees and expenses) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death at any time resulting therefrom sustained by any person or persons, including myself and anyone I bring to the on-or-off-site activities with me or on account of damage to property, arising out of or in consequence of my participation in agility activities, howsoever such injuries, death, or damage to property may be caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person, or by any other cause or causes.

I CERTIFY that I am the actual owner of the dog(s), or that I am the duly authorized agent of the actual owner of the dog(s) participating. I affirm that I and the participating dog(s) are in good health, capable of participating in agility activities, and I accept as my personal risk the consequences of such participation. I certify and represent that the dog(s) participating is (are) not a hazard to persons or other dogs. I agree to conduct myself in accordance with the instruction given and other rules as outlined. I declare this Waiver and Assumption of Risk is binding on me, my heirs, executors, administrators and assigns.
